

Pattershall Oil Limited and CardLink Systems Limited \$1,000 Credit Prize Draw – Full Terms and Conditions

Entry:

1. By entering this competition, entrants agree to be bound by these Terms and Conditions. Information on how to enter this competition forms part of these Terms and Conditions.
2. In order to gain entry to the competition, entrants must:
 - i. open a new account with CardSmart Fuel Card between 26 March 2018 and 30 June 2018, and use at least one of the CardSmart Fuel Card at least once during the competition period.
3. For the purposes of these Terms and Conditions:
 - i. “Competition Period” is between 26 March 2018 and 30 June 2018.
4. There is a limit of one entry to the competition per customer, regardless of how many fuel cards the account has.

Prize and Winning:

5. The prize is for \$1,000 worth of credit to the CardSmart Fuel Card account (“Prize”).
6. The Prize cannot be exchanged for any other product or for cash. The Prize must be redeemed in accordance with these Terms and Conditions.
7. The Prize winner will be determined by a random draw from all eligible entries made during the Competition Period. The draw will be made approximately 30 days after the end of the Competition Period (“Draw Date”). The winner will then be contacted by CardLink Systems Limited by email or telephone.
8. If CardLink Systems Limited is unable to contact the winner after a period of two weeks following the Draw Date, having made reasonable efforts to do so, that winner’s entry will be declared invalid.
